

MINUTES OF A JOINT MEETING OF THE BOARDS OF SUPERVISORS OF THE TOWNS OF BARRON AND STANFOLD IN BARRON COUNTY, WISCONSIN, Held at the office of F. E. Van Sickle at Barron, Wisconsin, called by each Chairman for the purpose of apportioning roads and bridges on the highway on the boundary of the two towns.

PRESENT: Town of Barron, William Miller, Chairman, Adolph Helgeland, Magnus Hansen, Supervisors, and Carl Nordby, Clerk.
Town of Stanfold, Peter Peterson, Chairman, Sig Brown and Albert Johnson, Supervisors, and William Phillipsen, Clerk.

Discussion on the question of apportioning the highway and bridges and what are to be regarded as bridges and what are to be regarded as equalizing culverts.

Motion made by Peterson and seconded by Miller that the following resolution be adopted:

"Whereas, it is desirable that the towns of Barron and Stanfold agree on the maintenance and repair of the highways and bridges located on the boundary between the two towns.

Now, Therefore, It is Resolved that the Town of Barron shall henceforth be responsible for the maintenance, repair and rebuilding of that portion of the highway located between sections Three (3), Four (4) and Five (5) of the Town of Barron on the south and sections Thirty-four (34), Thirty-three (33) and Thirty-two (32) of the Town of Stanfold on the north; and that the Town of Stanfold shall henceforth be responsible for the maintenance, repair and rebuilding of that portion of the road located between Sections One (1), Two (2) and Six (6) of the Town of Barron on the South and Sections Thirty-six (36), Thirty-five (35) and Thirty-one (31) of the Town of Stanfold on the North.

Be It Further Resolved that henceforth and following bridges or culverts shall all be maintained and rebuilt at the joint expense of the two townships:

1. The bridge located across the Yellow River between Section Five (5) of the Town of Barron and Section Thirty-two (32) of the Town of Stanfold;
2. The bridge or culvert located between the Northwest Quarter of the Northwest Quarter of Section Four (4) in the Town of Barron and the Southwest Quarter of the Southwest Quarter of Section Thirty-three (33) in the Town of Stanfold;
3. The bridge or culvert located between the Northeast Quarter of the Northwest Quarter, Section Four (4) of the Town of Barron and the Southeast Quarter of the Southwest Quarter of Section Thirty-three (33) of the Town of Stanfold;

Quarter of the Southwest Quarter of Section
Thirty-five (35) of the Town of Stanfold;

5. The bridge or culvert located between the Northwest Quarter of the Northeast Quarter of Section Two (2) in the Town of Barron and the Southwest Quarter of the Southeast Quarter of Section Thirty-five (35) in the Town of Stanfold;
6. The bridge located on the main course of Barker Creek between the Northwest Quarter of the Northeast Quarter of Section Two (2) in the Town of Barron and the Southwest Quarter of the Southeast Quarter of Section Thirty-five (35) in the Town of Stanfold.

All other bridges or culverts located on the road located on the boundary between the two towns shall be maintained, repaired and rebuilt at the sole expense of the town to which the road has been apportioned on which such bridge or culvert is located.

Be It Further Resolved that any repairs costing less than Twenty-five Dollars on any joint bridge or culvert shall be borne solely by the board on whose portion of the road it is located.

Be It Further Resolved that the approaches to all bridges or culverts hereinbefore designated as joint bridges or culverts shall be maintained, repaired, and rebuilt by the town on whose portion of the road said bridge or culvert is located.

Motion carried by unanimous vote.

Meeting adjourned.
